WHAT IS THE RIGHT SHADE FOR ME?

- **Black:** Suitable for root application on hair that has been previously colored with Naturtint® 1N or 2N.
- **Dark Brown:** Suitable for root application on hair that has been previously colored with Naturtint® 2N or 3N.
- **Light Brown:** Suitable for root application on hair that has been previously colored with Naturtint® 4N, 4G, 5N, 5G or 5.7. Not suitable for copper, red, or intense shades.
- **Light Mahogany:** Suitable for root application on hair that has been previously colored with Naturtint® 4M or 5M.
- **Dark Blonde:** Suitable for root application on hair that has been previously colored with Naturtint® 6N, 6G, 6.7, 7N or 7G. Not suitable for copper, red or intense shades, or hair darker than a level 4.
- **Light Blonde:** Suitable for root application on hair that has been previously colored with Naturtint® 8N, 8G, 9N or 10N. Not suitable for copper, red or intense shades, or hair darker than a level 6.

Please read the application instructions carefully.

STEP 1: PREPARE THE MIXTURE

Make sure that the hair is clean and dry because product build-up can alter the results. We recommend using the product one day after washing, to allow the scalp to restore its natural protective barrier. This will help protect your scalp during the coloring process. Comb your hair before application, leaving the roots visible: the top part, crown and temples depending on the hairstyle.

Always wear the gloves that are provided and make sure to have all the necessary items on hand.



- 1.** Place a **towel** over your shoulders to protect your clothing from stains.



- 2.** Put on the **gloves** that are included in the kit and do not remove them throughout the hair color process.



- 3.** Remove the caps of the **Root Retouch Colorant (A)** and **Color Developer (B)** containers, and pour the contents into the mixing bowl. Using the applicator brush, mix the products for 2 minutes until the ingredients are thoroughly combined.

STEP 2: APPLY THE COLOR



- 1.** Apply the mixture to your roots using the applicator brush, ensuring the hair is completely covered. Do not massage the product through the rest of the hair.



- 2.** Leave the mixture to develop for 10 minutes (20 minutes if you have stubborn gray).

STEP 3: RINSE AND CONDITION



- 1.** Once the development time has elapsed, gently massage the hair, using gloved hands, while thoroughly rinsing it with warm water until the water runs clear.



- 2.** Wash your hair with a natural pH shampoo and rinse again with plenty of water to ensure all the hair color is removed.



- 3. Very important:** Apply the **Protective Conditioner (C)** to wet hair, massaging it from roots to ends. Leave on for 2 to 5 minutes and rinse thoroughly with plenty of water. Comb and dry as usual.

STRAND TEST

The final results will depend on the color, thickness and overall condition of your hair. We recommend performing a strand test to confirm the final result and the corresponding development time.

- 1.** Using utensils and a small plastic container, such as a bottle cap, mix a small amount of the **Colorant (A)** with an equally small amount of the **Color Developer (B)**. Do not use metal utensils.

- 2.** Wearing the gloves provided, apply to a small section of hair at your roots.

- 3.** Rinse the tested area after 10 minutes. In the case of stubborn gray or thick hair, or to achieve a more intense color, leave the mixture on for an additional 5-10 minutes.

- 4.** Gently dry the section of hair to reveal the final result, remembering to take a note of the exact development time. This will be the time you must wait while coloring your hair.



SAFETY INSTRUCTIONS: READ AND FOLLOW THE INSTRUCTIONS BEFORE USE. CAUTION: HAIR COLORANTS CAN CAUSE SEVERE ALLERGIC REACTIONS.

IMPORTANT:

This product contains ingredients which may cause skin irritation on certain individuals and a preliminary test according to accompanying directions should first be made (48h before each use). This product must not be used for dyeing the eyelashes or eyebrows; to do so may cause blindness.

Contains phenylenediamines (toluenediamines) and hydrogen peroxide. This product is not intended for use on people under the age of 16. Temporary "black henna" tattoos may increase the risk of an allergic reaction. The ratio for mixing colorant and the developer must always be 1:1.

DO NOT COLOR YOUR HAIR IF:

- There is a rash on your face or you have a sensitive, irritated or damaged scalp.
- You have ever experienced a reaction after coloring your hair.
- You have experienced a reaction to a temporary "black henna" tattoo in the past.

SKIN SENSITIVITY TEST:

ANY COSMETIC PRODUCT CAN CAUSE AN UNEXPECTED ALLERGIC REACTION AND, FOR THIS REASON, A SKIN SENSITIVITY TEST MUST ALWAYS BE PERFORMED 48 HOURS, BEFORE COLORING YOUR HAIR - EVEN IF YOU ARE A REGULAR USER OF HAIR DYES. If your scalp is irritated, or you have damaged or broken skin, do not perform the skin sensitivity test and do not color your hair until your scalp has fully healed.

Even if a sensitivity test has been carried performed, you may still experience an allergic reaction when coloring your hair. The sensitivity test is an important precaution but it does not guarantee that there will be no allergic reactions in the future.

- Remove any earrings. Clean a small surface behind the earlobe or on your inner elbow with cotton and a little alcohol.

- Using plastic utensils and a plastic bowl, mix a small amount (in equal measures) of the **Colorant (A)** and the **Color Developer (B)** until fully blended. Do not use a metal or ceramic bowl, or metal utensils. Reseal both bottles immediately to preserve the contents for the full application 48 hours later.

- Mix the two products until a homogeneous gel is obtained.

- Apply the mixture to the cleaned area. Allow it to dry and then apply two more layers, allowing the areas to dry in between each application.

- Leave the test mixture on the skin for at least 48 hours without washing or touching the test area.

- If you experience any reaction, such as swelling, redness, blistering, rash or itching, in or around the test area, then you are sensitive to one or more of the ingredients contained in the formula. RINSE IMMEDIATELY AND DO NOT USE THIS PRODUCT ON YOUR HAIR.

SPECIFIC PRECAUTIONS:

If you experience a reaction during the application, such as stinging, burning, irritation or a rash on the scalp, rinse immediately and discontinue use. If you experience difficulty breathing, a rapidly-spreading skin rash, dizziness, faintness, and/or swelling to the eyes/face, seek immediate medical attention. Consult a doctor before coloring your hair again.

- Keep out of reach of children.

- Always wear the gloves that are provided.

- Avoid contact with eyes. Rinse immediately with plenty of water if the product comes into contact with eyes. Visit your doctor if irritation persists. (If you wear contact lenses, remove them before rinsing.)

- This product is designed to only be used on the scalp area. Do not use it to dye eyelashes or eyebrows, or any other areas, such as facial hair.

- Avoid unnecessary contact with the skin.

- Do not inhale or ingest the product.

- Prepare and apply the mixture in a well-ventilated area.

- If your hair has been permed, bleached or relaxed recently, wait at least 2 weeks before applying Naturtint® Root Retouch.

- Always perform the color strand test to confirm whether the desired results will be achieved.

- Seek medical attention if, during the days following application, you experience itching, redness, spots, swelling, blisters and/or oozing of the eyes, face and/or scalp.

- Consult with your doctor any questions regarding your specific sensitivity to hair color.

- We recommend using Naturtint® Root Retouch 15 days after applying your regular color, when the roots are visible but still short. Apply primarily along the hairline around the face, top part and temples.

- Naturtint® can be used if your hair has been previously dyed using henna or progressive color, but only after the color has completely grown out or been removed. THE RISK OF AN ALLERGIC REACTION MAY INCREASE IF YOU HAVE A TATTOO, SO BE SURE TO FOLLOW THE INSTRUCTIONS.
